## Performer's Letter of Intent

The Nutcracker Ballet is scheduled to be performed at McMorran Place Theater  
Port Huron, Michigan on December 1st, 2nd, and 3rd, 2017

If I accept the part(s) I have been offered, I agree to the following:

- I am obligated to pay a **\$65** participation fee. The fee is due upon acceptance of the part(s) I am offered. Failure to pay the fee by AUGUST 31, 2017 or make other arrangements with The Nutcracker Ballet will be considered as a "drop" from the cast and my part(s) will be given to another person.
- Casting decisions are based on dancer ability, costume requirements, and overall suitability to the production. As rehearsals progress, I may be required to perform additional or fewer roles, or to change roles altogether.
- There will be no calendar conflicts before committing to perform in The Nutcracker. If there is a conflict that cannot be avoided, I must inform The Nutcracker *in writing prior to my acceptance of part(s)*.
- Depending on the number of cast members in the show; I may need to share a costume. I must return my costume(s) to wardrobe before leaving the theater following my last performance. At no time is any costume allowed to leave the Masonic Temple or McMorran Theater.
- I will wear *proper* ballet attire for all practice sessions. For females: hair secured in a classical ballet bun, black leotard, pink tights and proper shoes for your part (pointe shoes for pointe dancers, all-white gym shoes or jazz shoes for acrobat, ballet slippers for all non-pointe ballet dancers). For males: shorts, T-shirt, and either jazz or ballet shoes.
- I will be required to wear make-up specific to my part(s).
- I am required to attend all of my scheduled practice sessions at the Masonic Hall, and all of my scheduled McMorran Theater rehearsals and performances December 1<sup>st</sup>, 2<sup>nd</sup>, and 3<sup>rd</sup>, 2017. I am required to arrive *on time* for all of my scheduled practice sessions and performances. Rehearsals **may** take place Thanksgiving weekend and are required.
- Any unexcused absences from practices, rehearsals or performances will not be tolerated and may constitute immediate dismissal from the cast.
- I understand that video recording or photography is not permitted during theater dress rehearsals or performances.
- I will be 100% committed to the production and will conduct myself professionally at all times.
- All travel, supplies, and meal expenses are my responsibility.
- The Nutcracker Ballet Theatre Company is not responsible for any injuries or loss of property incurred as a direct result of the practice sessions, rehearsals or productions.
- I realize that as a cast member my child/children may be given a partnered role that may require physical contact with another dancer.
- I realize that if my child/children are cast in the Nutcracker, one adult family member of her/his family is required to volunteer time.
- The Nutcracker Ballet Theatre Company reserves the right to dismiss any dancer that does not adhere to or support this Performer's Letter of Intent or the production in general.
