Performer's Letter of Intent

The Nutcracker Ballet is scheduled to be performed at McMorran Place Theatre located in Port Huron, Michigan on December 10, 11, and 12, 2010. If I am selected to perform, I agree to the following:

- If I am cast, I am obligated to pay an all inclusive participation fee of \$68.00. \$25.00 of this fee is due on April 25, 2010 for auditions. The balance of \$43.00 is due by September 1, 2010. This fee will cover: Costuming fee, general make-up supplies, cast luncheon and a cast tee shirt. I will be required to purchase my own false eyelashes, lipstick, eye shadow(s), mascara, and eyeliner.
- Failure to pay my participation fee by September 1, or to make other arrangements will be interpreted as a "drop" from the cast and my part will be given to another dancer.
- I will notify The Nutcracker Ballet Theatre of my acceptance or rejection of the part I have been offered on or before September 1, 2010. (Phone (810) 824-8044) The remainder of my participation fee is due at this time.
- I may need to share a costume. Many parts are double cast in order to give all dancers the opportunity to perform.
- I must return my costume to the wardrobe mistress before leaving the theater following my last performance.
- At no time is a costume allowed to be removed from Masonic Temple or McMorran Theater.
- If I am cast in all 4 performances, I understand that I am not allowed to leave McMorran Theater between the afternoon and evening performances.
- I understand that videotaping is not permitted during dress rehearsals or during the performances.
- I am responsible to attend all practice sessions, technique classes and performances. I understand that dress rehearsal is mandatory and I agree to attend all scheduled rehearsals during the week of December 6th through December 12th 2010.
- I am responsible to arrive on time for all practice sessions and performances.
- I understand that I am to come dressed in the proper ballet attire for all practice sessions. For female dancers: hair secured in a "Classical Ballet" bun, black leotard, pink tights, ballet shoes, pointe shoes (for pointe dancers), character shoes for Spanish parts, tennis shoes for acrobats and jazz shoes for Russians. Male dancers should wear shorts, t-shirts, and either jazz or ballet shoes.
- I agree to work cooperatively with all cast and crew members.
- I agree to conduct myself professionally during practice sessions and performances.
- I understand that all travel, supplies, and meal expenses are my responsibility.
- I understand that the Nutcracker Ballet Theatre Company is not responsible for any injuries or loss of property incurred as a direct result of the practice sessions, rehearsals, or productions.
- I understand that the Nutcracker Ballet Theatre Company reserves the right to dismiss any dancers that do not adhere to or support the Performer's Letter of Intent.
